# WHAT IS BIODIESEL

Biodiesel refers to a vegetable oil or animal fat-based diesel fuel consisting of long-chain alkyl (methyl, ethyl, or propyl) esters. Biodiesel is typically made by chemically reacting liquids (e.g., vegetable oil, soybean oil, animal fat tallow) with an alcohol producing fatty acid esters.

Biodiesel is a drop-in biofuel and thus meant to be used in standard diesel engines and is thus distinct from the vegetable and waste oils used to fuel

## JATROPHA BIODIESEL

The crude oil harvested from jatropha seeds needs to be processed into a diesel before it can even begin to compete with other energy sources. Jatropha biodiesel is the processed form of jatropha oil and gets its power from the energy-rich bonds

## ADVANTAGE OF BIODIESEL FUEL



### BETTER POWER

- Better combustion ensures more power as it has higher CETANE rating and more oxygen



### INCREASED MILEAGE

- Higher CETANE rating around 51 than Petro-Diesel of around 47
- Higher DENSITY of about 874 kg/m<sup>3</sup>



### LESS MAINTENANCE

- Better lubrication assures higher engine life as it has higher VISCOSITY (4 to 5%) than Petro-Diesel



### ECONOMICAL

- Cheaper than any other diesel in the market as it will always cost less.



### ECO-FRIENDLY

- Made from vegetable oil and contains practically no sulfur as compared to petro-diesel which contains SULPHUR of about 50ppm so it reduces pollution from engines and as it has no sulphur so no ACID RAIN
- Biodiesel has higher oxygen content (usually 10 to 12 percent) than petroleum diesel. This should result in lower pollution emissions.
- Biodiesel is much less toxic than petroleum diesel. This can be a real benefit for spill cleanups.
- Biodiesel fuel is a renewable energy source unlike petroleum-based diesel.
- One of the main biodiesel fuel advantages is that it is less polluting than petroleum diesel.

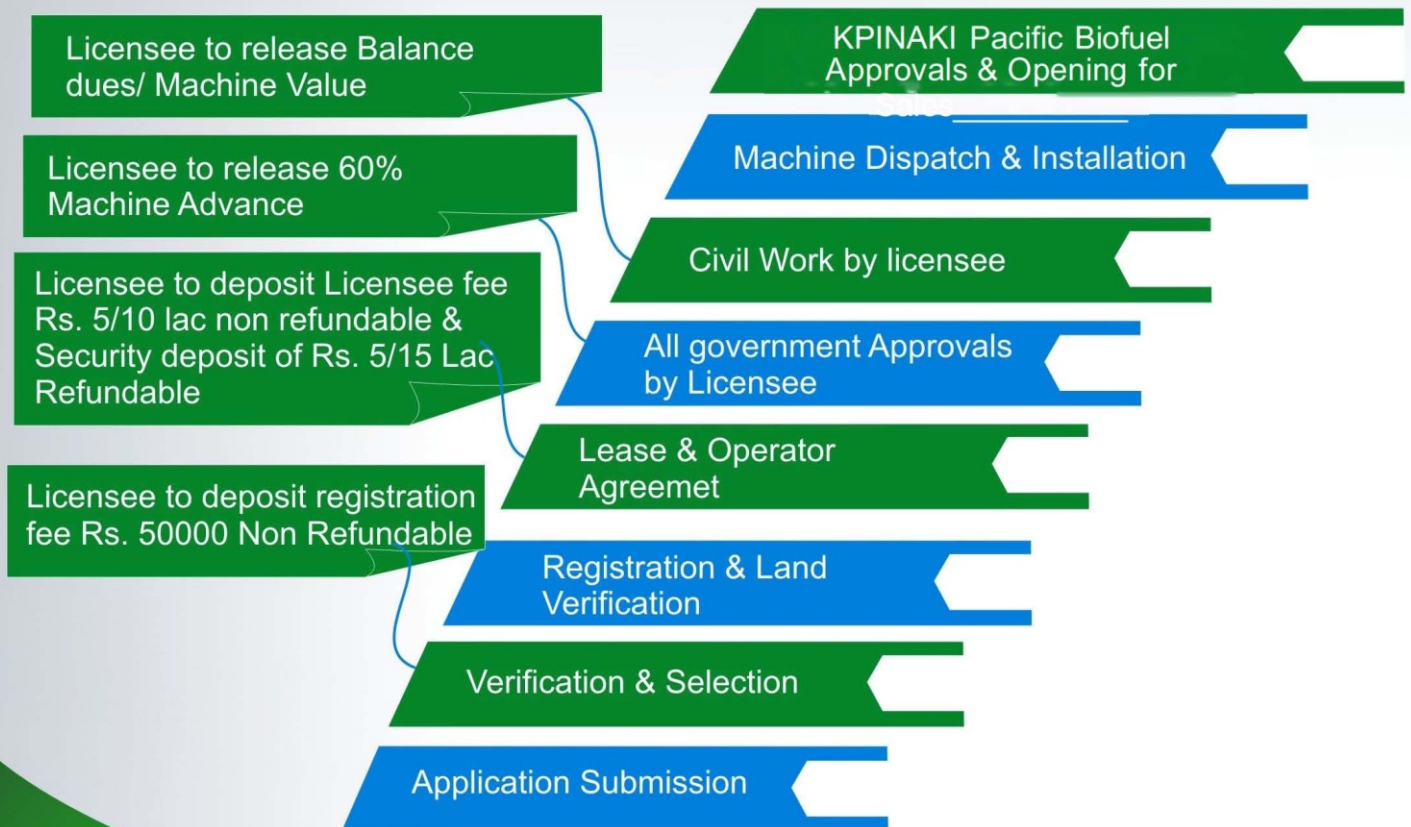

### BIO DIESEL

## बायोडीजल

### बायोडीजल पंप मालिकों के लिए जनहित में प्रसारित विषय – बायोडीजल के बारे में लीगल जानकारी सतर्कता, बचाव के उपाय

अभी अधिकांश बायोडीजल पंप मालिक बायोडीजल की shorts & supply से परेशान हैं, अभी सरकार की तरफ से भी कुछ कार्यवाही शुरू की गयी है। यह तो आप जानते हैं की 94 C से कम टेम्परेचर पर जलने वाला पदार्थ जो प्रायः पेट्रोलियम ही होता है क्योंकि BIS स्टैंडर्ड के अनुसार बायोडीजल तो 120 C से अधिक पर ही FLASH होता है।

अधिकांश पंप मालिकों के यहां केवल डेनसिटी (Density) देखने जांचने का मीटर होता है जो की आंशिक सूचना देता है।

आप बहुत आसानी से समझ सकते हैं की जिस प्रोडक्ट की (DENSITY) कम होगी उस में FLASH POINT भी कम ही होगा जो पेट्रोलियम पदार्थ होने की तरफ संकेत करते हैं वर्तमान में 0.82 से 0.85 तक कस माल प्रचन में है जो बायोडीजल के BIS स्टैंडर्ड 15607 की मिनिमम डेनसिटी के दायरे में नहीं आता है वह इसे मैच नहीं करता है।

1. अधिकांश पंप मालिक अनजाने में ही महत्वपूर्ण कानून का उल्लंघन कर अपराध हो रहे हैं, इस प्रकार कम डेनसिटी व कम FLASH POINT का बायोडीजल के नाम से अन्य माल की बिक्री से एक्सप्लोसिव एक्ट के सेक्शन 2 का उल्लंघन हो रहा है।

"Petroleum Class 'C' & means petroleum having a flash point of 650C and above but below 930C. "Flash Point" of any petroleum means the lowest temperature at which it yields a vapors which will given a momentary flash when ignited] determined in accordance with the provisions of chapter 2 of the Act and Rules made thereunder.

कानून की अवहेलना करने पर पंप सील हो सकता है अभी बायोफ्यूल ऑथरिटी भी सक्रिय है। जिन लोगो ने बायोडीजल के नाम पर पंप खोल लिए हैं और पेट्रोलियम पदार्थ बेच रहे हैं उन पर कार्यवाही प्रस्तावित है। आपके एरिया का एक सामान्य पुलिस मैन भी एक्सप्लोसिव एक्ट में केस बुक कर सकता है।

2. "हमारा उद्देश्य बायोडीजल पंपों का अस्तित्व बनाये रखना है एवं उन्हें सुरक्षित करना है की वे कानूनी शिकंजे में फसने से सुरक्षित रहे " .
3. गलत माल या पेट्रोलियम मिक्स माल को पहचान के कुछ ज़रूर आप स्वयं करके ज्ञात कर सकते हैं की आपको जो माल प्राप्त हो रहा है उसकी क्या स्थिति है।
  - (a) सूँघ कर—पेट्रोलियम जैसी खुसबू केरोसिन, M-T-O थिनर टाइप होगा।
  - (b) इंटेंसिटी—यदि डेनसिटी 0.860 से कम है तो FLASH POINT 60C & 70C के आस पास होगा और यह प्रोडक्ट EXPLOSIVE ACT में आवेग क्योंकि FLASH POINT 90C से कम है।
  - (c) जो पंप मालिक वास्तव में माल की जाँच करना चाहते हैं और सतर्क रहना चाहते हैं उन्हें हम फ्री ट्रेनिंग देंगे एवं मुफ्त केमिकल भी जिससे वे 2 मिनट में अपने पंप पर सरलता से बायोडीजल की जाँच कर सकते हैं इसके लिए आप हमसे सम्पर्क एवं आवेदन कर सकते हैं।
